NET THIRTY (30) DAYS UNLESS OTHERWISE SPECIFIED IN INVOICE

If any invoice is not paid when due, Customer agrees to pay interest on the unpaid balance at 1.5% per month. If any invoice is turned over to an attorney for collection, Customer shall pay all costs of collection, including court costs and reasonable attorneys' fees, and expenses. This formal Credit Application shall constitute an "evidence of indebtedness" for such purposes under N.C.G.S. §6-21.2. If Customer returns any goods to Laminatemoldings (hereinafter "Laminatemoldings") for any reason whatsoever, the Customer shall pay to Laminatemoldings twenty percent (20%) of the invoice amount for each returned item as a restocking fee.

The parties agree that all questions with respect to the construction of this Agreement and the rights and liabilities of the parties hereto shall be determined in accordance with the provisions of the laws of the State of North Carolina. Jurisdiction and venue for the purposes of this Agreement shall be vested in Vance County, North Carolina and the parties agree that all disputes regarding this Agreement shall be brought in the General Court of Justice for Vance County, North Carolina and no other venue.

This Agreement constitutes the entire agreement between the parties and is binding upon the parties and their heirs, successors and assigns. This Agreement supersedes any and all other agreements, either oral or in writing, among the parties hereto with respect to the subject matter hereof. No change or modification of this Agreement shall be valid unless the same shall be in writing and signed by the parties.

This guarantee shall be deemed to be a contract made under and shall be construed in accordance with the laws of the State of North Carolina. I/We agree that any dispute arising out of this guarantee shall be adjudicated in the General Court of Justice of Vance County, North Carolina and in no other forum. For that purpose, I/We hereby submit to the jurisdiction of the state courts of North Carolina, agree that the state courts in Vance County, North Carolina are a convenient forum and agree not to raise as a defense that such courts are not a convenient forum.
